The following activities are to be completed within the stipulated time from the date of receiving application till issue of approval letters/ Certificates to applicant/allottee and as such following time limits are fixed for these activities:

Time limit for Building construction Permissions

Mandate Time Lines such that the following approvals /NOCs are provided within 45days

a.	Approval of Development plan/ Building plan.	30 days
b.	Plinth inspection to be completed	7 days
c.	Issue of Occupancy certificate (7 days for inspection + 1 day for issuing certificate)	8 days

All Development Officers/concerned officials are hereby instructed to complete the aforementioned activities within stipulated in strict compliance. Any failure in this regard, disciplinary action will be initiated against concerned officials/officers.
