1. KIADB Residential Layout Area, Vasanthanarasapura Industrial Area, Tumkuru

## **General Terms and Conditions**

- 1. The auction purchaser should be a Citizen of India.
- 2. The auction purchaser shall be an entrepreneur/ employee working in the Industrial unit located in the same district or adjacent district.
- 3. The auction purchaser who is an entrepreneur may be a Partnership Industrial unit/ Proprietorship (Individual). The Partnership Industrial unit/ Proprietorship (Individual) should be a registered firm.
- 4. The auction purchaser shall upload the following document supporting the existence of running unit in the district:
  - (i) For Entrepreneur/ Partnership Industrial unit/ Proprietorship
    - a) Unit under production certificate issued by Joint Director, Department of Industries & Commerce, Govt. of Karnataka
    - b) Electricity Bills from January 2022 to December 2023
    - c) Invoices for receiving the orders and supply of the products

## (ii) For Employee

- (a) Certificate issued by the Employer indicating the Employee is currently working in the organization and has completed period of minimum 1 year in the organization.
- (b) Salary Slips from January 2023 to December 2023
- 5. Address proof: Any one of the following documents attested by a Gazette Officer/Notary / Embassy Office (in the case of NRIs) shall be uploaded.
  - a) Voter ID,
  - b) Driving License,
  - c) Passport,
  - d) Unique Id Number (Aadhaar),

- 6. Uploading of PAN Card in e-auction portal is compulsory (Should be attested by Gazette Officer/Notary/Attested by Embassy Office in case of N.RI).
- Signature & Photo Identity should be uploaded on the e-Auction portal (Attested by a Gazette Officer/Notary/Embassy Office (in case of N.RI's). Please download the prescribed format.
- 8. The Bidder/ Auction purchaser shall mention correct e-Mail address, mobile number and landline number while participating in the e-Auction. The bidder whose name is registered in the e-procurement is final and Residential Plot will not be transferred to any other name.
- 9. The Bidder/Auction purchasers who desire to have the Residential Plots jointly registered should upload the details of the persons concerned on the e- portal. The relationship of such person should be clearly mentioned.
- 10. EMD amount is fixed at Rs.1.00 lakh (Rupees one Lakh only) per Residential Plots and this amount along with the e-Auction fee should be remitted as mentioned on the e-Procurement portal. This amount should not be remitted to the KIADB account as the EMD amount is maintained by e-procurement.
- 11. All legal proceedings in respect of the auction of Residential Plots are subject to the Courts located in the respective jurisdictional District of Residential layout Industrial Areas and Bengaluru city.
- 12. KIADB reserves the right to withdraw the Residential Plots notified for auction at any time during auction period without assigning any reasons.
- 13. KIADB reserves the right to accept or reject the bid made by the successful bidder without assigning any reasons.
- 14. Demanding/ Advice letters will be sent by e-Mail to successful bidders (highest bidders) to remit 25% of the total cost after deducting EMD amount of Rs.1.00 Lakh for Residential Plots.
- (a) The successful bidder shall remit the balance amount within five (5) days (excluding bank holidays if any) from the receipt of the Advice letters sent by e-mail, to the below-mentioned KIADB Bank Account; and the challan for remittance should be submitted to the Accounts Officer, KIADB Head Office, 5<sup>th</sup> floor, East Wing, Khanija Bhavan, Race Course Road, Bengaluru-560001.

- 15. EMD amount of unsuccessful bidders will be released to their Account within forty five (45) days from the last date of auction.
- Where 25% of the total cost is not remitted as mentioned in 14/ 14(a), the EMD amount of Rs.1.00 lakh for Residential Plots shall be forfeited by the KIADB
- 17. Successful bidders/Auction Purchasers after remitting 25% of the final bid amount should pay the balance 75% amount within 60 days of receiving the allotment letter from KIADB.
- 18. Bidder / Auction purchasers shall abide the rules of KIADB prescribed for allotment of Residential Plots.
- 19. While participating in the e-auction,

(a) In case if there is only one bidder for a particular Housing site, the bid will be rejected and EMD will be refunded.

(b) The bid amount should exceed the fixed basic price of the Residential Plot by a minimum of 10%, or the bid will be rejected. However, KIADB reserves the right to accept or reject any bid/ all the bids without assigning any reasons.

- 20. Residential Plots will be auctioned on "As in where is Basis". There is no provision for change of Residential Plots.
- 21. Bidder/Auction Purchaser has to read all the terms and conditions before bidding and shall participate accordingly.
- 22. The Bidder/Auction Purchaser can bid for any number of Residential Plots, provided submitting separate EMD for each Residential Plots.
- 23. The auction Purchase or bidder are one and the same.
