### NOTIFICATION

Sub: Amendment regarding implementation of Central Inspection System.

Ref: 1) Notification No. CI 209 SPI 2017 dated 09.10.2017.  
2) Ease of Doing Business Action Points under Business Reforms Action Plan 2019, Govt. of India.

Government of Karnataka has already institutionalised a Central Inspection System for undertaking the compliance inspections for establishments under various acts/ rules of the Labour Department, Department of Factories, Boilers, Industrial Safety & Health and Karnataka State Pollution Control Board (KSPCB).

Further, to the Government Notification mentioned above at (ref. 1), in addition to the list of acts/rules/laws of 14 services of the above departments indicated for Central inspections, The Boilers Act, 1923 is also included in the reforms implementation of Business Reform Action Plan 2019 GoI along with additional measures.

The Government Notification No. CI 209 SPI 2017 dated 09.10.2017 was issued considering 14 services under the acts and rules of Labour Department, Department of Factories, Boilers, Industrial Safety & Health and Karnataka State Pollution Control Board. In addition to the list of acts/rules/laws of the concerned departments indicated for Central inspections The Boilers Act, 1923 is also included in the reforms implementation in Central inspection system for the year 2019.

To facilitate and reduce the requirements and make the existing Institutionalized Central Inspection System more effective, it has made responsible for undertaking compliance inspections of the departments concerned by taking following additional measures.

- Mandated that inspections (except in case of complaint based inspections) shall be limited to the checklist only.
- Mandated online submission of inspection report within 48 hours to the Department/Central Inspection System.
- Mandated that the same inspector will not inspect the same establishment twice consecutively.
- Inspection reports made available online.
